### **Terms of Service of the FSZK Website**

### § 1 DEFINITIONS

- 1. FSZK Website Administrator The School with Class Foundation, with a registered office at ul. Śniadeckich 19, 00-654 Warsaw, entered into the register of associations, other social and professional organizations, foundations and public health care institutions and in the register of entrepreneurs kept by the District Court for the Capital City of Warsaw, XII Commercial Division of the National Court Register, KRS number: 0000578705, NIP (VAT no.): 7010510338.
- 2. **Privacy Policy** the document informing about the processing of Users' personal data by FSZK, available on the Website.
- 3. **Regulations** a set of all provisions contained in the regulations of the School with Class Foundation's website.
- 4. Website the website made available to Users by FSZK via the www.szkolazklasa.org.pl domain.
- 5. **Work** any content published on the Website, including texts, graphics, photos, sounds, videos and other materials, graphic design of the portal and the selection and layout of the presented content.
- 6. **User** a natural person, a legal person or an organizational unit without legal personality, to which the law grants legal capacity, using electronic services available on the Website.

# § 2 GENERAL PROVISIONS

- 1. The Regulations define the rules of using the Website by Users.
- 2. By using the services and content available on the Website, the User agrees to the provisions of the Regulations and is obliged to comply with them.

# § 3 USE OF THE WEBSITE

- 1. The use of the Website is free of charge.
- 2. In order to use the Website, the User provides electronic equipment, Internet connection, web browser and other software required to use the Website.
- 3. In order to gain access to the courses made available on the Website, the User registers an account via the Website.



- 4. The User bears full responsibility for the content introduced by him or her and any damage caused thereby,
- 5. It is unacceptable for Users to post content which:
  - 5.1. is contrary to generally applicable law and the principles of social coexistence and good customs,
  - 5.2. calls for discrimination or hatred, in particular on grounds of race, religion, ethnicity, sexual orientation,
  - 5.3. promotes violence,
  - 5.4. contains vulgar or offensive content,
  - 5.5. contains content not related to the subject of the Website, including advertising content,
  - 5.6. may violate the personal rights of third parties,
  - 5.7. can be considered as spam (information unwanted by other Users, in particular in the form of a large number of comments with the same or similar content),
  - 5.8. is dangerous for the proper functioning of devices or IT systems, in particular containing links threatening the security of the proper functioning of devices or IT systems.
- 6. The User undertakes not to take actions aimed at disrupting the proper operation of the Website or any attempts to obtain access rights that are not vested in him.
- 7. In the event of posting content described in § 3.4, FSZK reserves the right to remove it without notifying its author. In extreme or repeated cases, FSZK reserves the right to remove the User from the Service and notify him of the reasons for removal.
- 8. In the case of taking actions described in § 3.5, FSZK reserves the right to remove the user from the Website and notify him of the reasons for removal.
- 9. Removal of the User in the manner provided for in § 3.6 and § 3.7 prevents the User from using the Website again.
